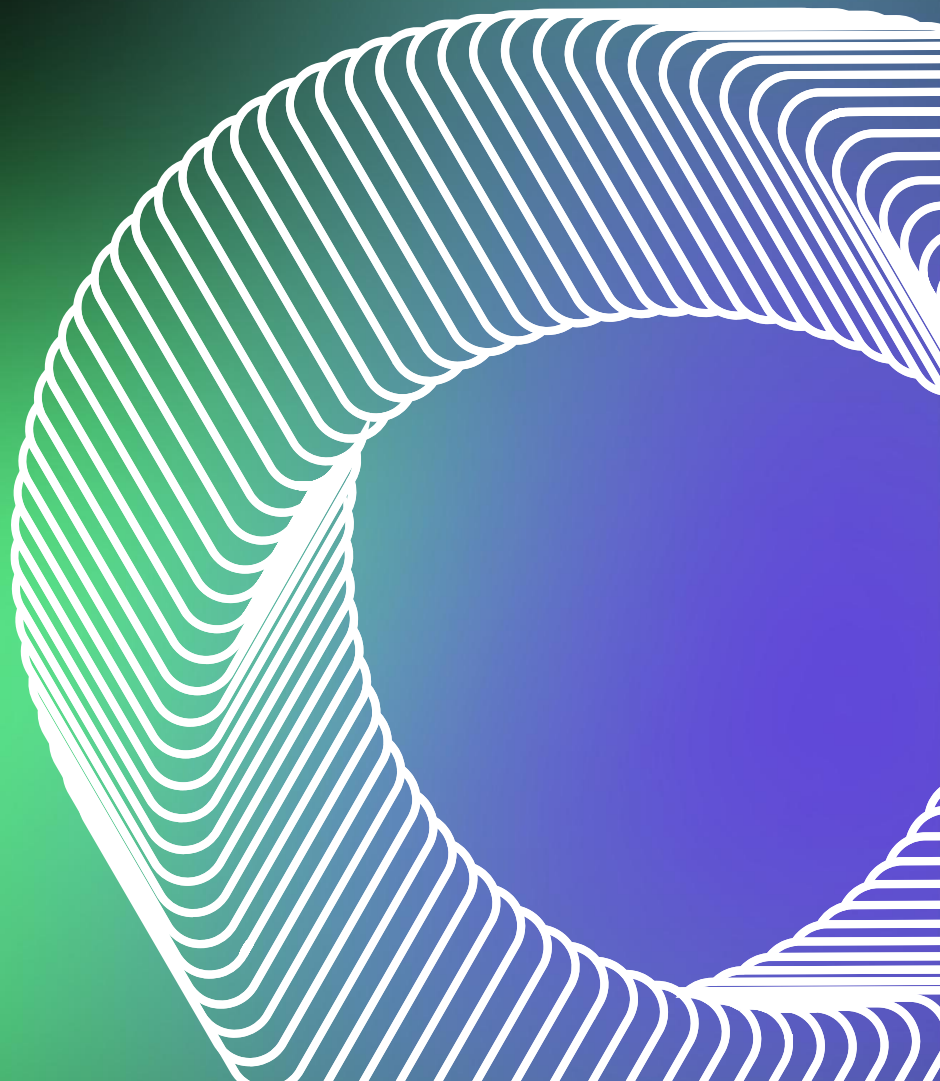

Implemented Initiatives

- **Renewable Energy:**
Cranmore's electricity supply is supplemented by an array of solar panels at our head office in Holywood Co Down, resulting in significant energy savings.
- **Low-Emission Fleet:**
Our entire fleet comprises exclusively electric vehicles (EVs), which eliminates emissions associated with conventional fossil fuel vehicles.
- **Local Community Initiatives:**
 - Tree planting programs
 - Beach cleaning initiatives
- **Sustainable Procurement:**
An internal policy prioritises local suppliers to reduce transportation and import-related emissions.
- **E-Waste Management:**
Active participation in WEEE recycling schemes.
- **Office Policies:**
Cranmore operates as a paperless office and conducts a successful bike-to-work scheme, encouraging environmentally friendly commuting practices.

Planned Future Measures

- Expansion of tree planting and beach cleaning volunteering initiatives.
- Extension of the cycle-to-work scheme to increase employee participation.
- Engagement with third-party carbon offsetting partners for further emissions reduction.

Evidence of Progress

- The cycle-to-work initiative has experienced a 10% increase in participation over the past 12 months. Full results and trends will be included in the 2026 reporting.
